# East Hanover Township, Lebanon County Municipal Building 1117 School House Road Annville, PA 17003 November 25, 2024

The Board of Supervisors convened in regular session at 7:30 pm. The meeting was open for the public to attend in person or via ZOOM. The meeting was recorded in order to aid in minute preparation afterwards.

Chairman - Edward Heagy Present Vice-Chairman - Stefan Wentling Present Secretary/Treasurer - Dennis Grubb Present

The meeting was called to order by Chairman, Edward Heagy. Heagy led the group in the Pledge of Allegiance to the American Flag.

#### Resident's Forum

Heagy invited questions/comments from the public.

No comments.

#### **Meeting Minutes Approval**

Heagy advised that the Meeting Minutes from the Public Hearing held Monday, October 28, 2024, at 7:00 pm and the Meeting Minutes from the Board of Supervisors' regular, monthly meeting held Monday, October 28, 2024, following the Public Hearing were prepared and ready for approval.

Grubb motioned to approve both sets of meeting minutes listed in the above paragraph. Wentling  $2^{nd}$  the motion and with all three Supervisors voting in favor, the motion passed.

#### **Payment of Bills**

Wentling motioned to pay the bills as presented. Grubb 2<sup>nd</sup> the motion and with all three Supervisors voting in favor, approval to pay the bills as presented was granted.

#### Solicitor's Report - Collen Gallo, Attorney

**Re.** Local Services Tax – Ordinance No. 2024-02 – Attorney Gallo was authorized at the last Board of Supervisors meeting to advertise the local services tax ordinance. The ordinance was properly advertised. The tax will be \$26.00 annually, to be paid by each employee of a business located within East Hanover Township.

Wentling moved to adopt Ordinance #2024-02 to approve the \$26.00 Local Services Tax effective January 1, 2025. Grubb 2<sup>nd</sup> the motion and with all three Supervisors voting in favor, the motion passed. Heagy explained that the Township Manager has been advised that ambulance service fees will be increased in the near future. Enacting this Local Service Tax is being done in an effort to help cover that increase in cost.

**Re.** Amendment to the Inter-Municipal Agreement between the Township of East Hanover and the Lebanon County Treasurer's Office – Resolution #2024-09 - Attorney Gallo advised that the Lebanon Co. Treasurer's Office collects the taxes for East Hanover Township. The current cost for this service is \$.50 per bill. That fee is going up to \$1.00 per tax bill.

Grubb motioned to adopt Resolution #2024-09 agreeing to pay the increased fee for tax collection to \$1.00 per tax bill. Wentling  $2^{nd}$  the motion and with all three Supervisors voting in favor, the motion passed.

**Re. Real Estate Tax Exemption Appeal – 201 Angle Road** – Attorney Gallo indicated that this matter is simply a "for information only" notice. She explained that these property owners took an appeal on their real estate tax bill, asking for their property to be tax exempt. They were denied by the Lebanon County Commissioners. Now, they are appealing that decision. The Township Supervisors chose not to send representation to the appeal.

#### Township Manager's Report - Erik Harmon

Harmon submitted a written report for the Board of Supervisors to review.

Re. I-81 Traffic Incidents – Harmon advised the Board of Supervisors that a township resident contacted him asking that the Township reach out to Rep. Russ Diamond about the high number of traffic incidents that occur on the stretch of interstate roadway that runs through East Hanover Township. Harmon expressed that he wonders if there is a structural issue with the roadway in this area, or, if the issue is a traffic volume/driver problem. Some discussion on the matter evolved. Someone stated that they heard that the roadway is 'smooth' in that location. Others stated that the increased volume of traffic from the area warehouses may be the simple reason for more incidents in the area. The area in question is defined as being from the I78/I81 split to the Manada Hill exit from I81. There are a higher number of incidents in the Southbound lane of this section of roadway. After reviewing the matter, the Board of Supervisors unanimously agreed to table the matter for the evening. Heagy stated that the Board of Supervisors may have more discussion in the future regarding this request.

**Re. Pension Contribution, Amended MMO** – Harmon explained to the Board of Supervisors that the Township gets reimbursed from the State for full-time employee's pension payment annually. Currently, the Township does not collect all of the reimbursement amount that we could be entitled to receive.

Wentling moved to increase the pension amount for employees to 11% effective 1/1/2024 and amend our MMO information appropriately. Grubb  $2^{nd}$  the motion and with all three Supervisors voting in favor, the motion passed.

**Re.** Consider CD Investment Renewals – Harmon stated that two of the Township's CD's held at Jonestown Bank are set to mature in December 2024. He asked the Board of Supervisors how they wished to handle the matters going forward.

Wentling moved to renew both CD's for a rate of not less than 3.75%, for a 12 month term. Grubb  $2^{nd}$  the motion and with all three Supervisors voting in favor, the motion passed.

**Re.** Health Insurance Premium Increase (5%) – Harmon advised the Board of Supervisors that notice has been received that the cost for employee Health Insurance will increase by 5% for 2025. This increase is still a minimal increase, compared to many other companies.

#### Road Foreman's Report - Howard Lerch

Lerch submitted a written report for the Board of Supervisors to consider.

#### Road Projects - Rettew

No new information to report.

#### Planning Commission Report – Marvin Smith, Chairman

**Re.** Mark Sallada – 10496 Allentown Blvd – Revised Stormwater Exemption Plan - The Planning Commission recommends the Board of Supervisors approve the revised exemption plan and record a new stormwater management exemption agreement.

Harmon explained that Sallada submitted a plan to build a pole building on his property, however, no driveway was shown on that plan. Later, it was discovered that he built a driveway, therefore, Sallada was asked to submit a revised plan showing the driveway. There will be a revised agreement coming.

Grubb motioned to approve the revised exemption plan and to record a new stormwater management exemption agreement in this matter. Wentling  $2^{nd}$  the motion and with all three Supervisors voting in favor, the motion passed.

## Re. 302 Investment Group, LLC – Jonestown Road, West of Yordy's Bridge Road – 6-lot Subdivision Plan Item #1

The Planning Commission recommends the Board of Supervisors approve the following waivers:

- a. SALDO §185-12.B.(1) Preliminary Plan Application
- b. SALDO §185-19.D Maximum Lot Depth to Width Ratio of 2.5 (Lot Nos. 6 & 7)
- c. SALDO §185-27.C.(8)(a) Installation of Curbs
- d. SALDO §185-27.C.(8)(b) Installation of Sidewalks
- e. SWM §172-23.b.1, b.3, 172-24 Utilize the standard worksheets from the Pennsylvania stormwater BMP manual in lieu of the Township worksheets.
- f. SWM §172.17.K To provide 1' of freeboard between the maximum pool elevation and the top of the embankment.

Wentling moved to approve the waivers, Items a through f listed above, as recommended by the Planning Commission. Grubb  $2^{nd}$  the motion and with all three Supervisors voting in favor, the motion passed.

#### Item #2

The applicant has requested a 90-day extension to the plan review deadline. The current deadline is December 18, 2024. The extended deadline would be March 18, 2025.

Grubb moved to allow the 90-day extension to the plan review deadline, making the new deadline March 18, 2025. Wentling 2<sup>nd</sup> the motion and with all three Supervisors voting in favor, the motion passed.

**Re.** Scott Stouffer, Minor Subdivision (Lot Addition – Park Drive) - The applicant has requested a 64-day extension to the plan review deadline. The current deadline is December 18, 2024. The extended deadline would be February 21, 2025.

Wentling moved to grant the deadline extension request, making the new deadline February 21, 2025. Grubb 2<sup>nd</sup> the motion and with all three Supervisors voting in favor, the motion passed.

- **Re. Zoning Map Amendments** The Planning Commission reviewed the public comments received at the 10/28/24 public hearing and the request from the owner of 10255 Jonestown Road. After a review of the comments, the Commission passed a motion to recommend the Board of Supervisors make the following revisions to the proposed Zoning Map amendments:
  - a. Remove the Rittel and Weaver properties from the proposed Low Density Residential zoning.
  - **b.** Change 10255 Jonestown Road from Agricultural zoning to General Commercial zoning, which better aligns with the current commercial use of the property.

Wentling moved to approve making the above-named revisions to the proposed Zoning Map amendments and to prepare and advertise the matter properly for eventual adoption. Grubb  $2^{nd}$  the motion and with all three Supervisors voting in favor, the motion passed.

**Re. Silo View Farms, 769 Ono Road - Reduction of Financial Security -** Light-Heigel has conducted a final inspection and provided a recommendation to reduce the amount of financial security held by the Township in this matter.

Grubb moved to reduce the amount of financial security held in this matter by \$17,698.76 and to continue to hold \$3,000. Heagy abstained from voting as he has financial interests in this matter. With Grubb and Wentling voting in favor, the motion passed and the financial securities being held will be reduced by \$17,698.76.

#### Re. Sanjay Patel, 25 Webster School Road - Reduction of Financial Security

Light-Heigel has conducted a final inspection and provided a recommendation to reduce the amount of financial security held by the Township to \$24,829.19.

Wentling moved to approve the reduction of the financial security being held in this matter to \$24,829.19. Grubb 2<sup>nd</sup> the motion and with all three supervisors voting in favor, the motion passed.

#### Re. Karen Lesher, 10106 Jonestown Road – Reduction of Financial Security

Light-Heigel has conducted a final inspection and provided a recommendation to reduce the amount of financial security held by the Township from Karen Lesher.

Grubb moved to allow a reduction in the amount of financial securities being held by the Township in this matter from 6,775.48 to 0. Wentling 0 the motion and with all three Supervisors voting in favor, the motion passed.

#### Property Maintenance & Zoning Report - Erik Harmon

Harmon submitted a written report to update the Board of Supervisors on these matters.

**Re.** 10880 Jonestown Road – This property owner constructed a detached garage and did obtain permits for this project. However, they have placed the downspouts to discharge right at the property line. Harmon has been communicating with them since July of this year asking them to correct this matter. No appropriate action has been taken.

Wentling motioned to authorize the Township Manager to take the appropriate action to correct the situation, including involving the Township Solicitor. Grubb 2<sup>nd</sup> the motion and with all three Supervisors voting in favor, the motion passed.

#### **Ono Sanitary Sewer - Ono Pump Station**

Brad Youst, Hanover Engineering – Youst provided a written report for the Board of Supervisors consideration.

#### Recreation Report - H.M. Levitz Memorial Park - Mike & Niccole Rice

Mike and Niccole submitted a written report of their work/information concerning the park for the Board of Supervisors to review.

- Re. Request to Donate 10% of the Profits from the Apple Cider Festival to a Non-profit Organization Last month, Mike and Niccole asked the Supervisors if they would consider giving 10% of the Apple Cider Festival profits to another non-profit organization as a way of giving back to the community for their support. The Board of Supervisors asked the Rice's to give them a recommendation of where they would like to see the support go. At this meeting, the Rice's suggested giving as follows:
  - 1. \$638 to the JOY Pantry (servicing the Northern Lebanon Community)
  - **2.** \$638 to Summit International School of Ministry Sky Camp (located within East Hanover Township and their students ran the children's activities at the Apple Cider Festival.)

Grubb moved to approve the donation of funds as indicated above. Wentling  $2^{nd}$  the motion and with all three Supervisors voting in favor, the motion passed. Niccole will send out the approved donations from the Apple Cider Funds.

**Re. Roadway Encroachment & Easement (61 Bullfrog Road)** – Harmon has been communicating with the property owner of 61 Bullfrog Road regarding a potential easement agreement for the apparent roadway encroachment. The property owner may be interested in applying for a driveway permit to access Levitz Park Road. All three Supervisors were in favor of tabling this matter for now. They would like more time and information to look into this matter.

#### **Northern Lebanon Fire and Emergency Services Reports**

October reports were not submitted.

#### <u>Greater Lebanon Refuse Authority – Frankleen Gibson</u>

Gibson did not have any new information to report.

**2025** Budget — The proposed 2025 Budget was available for review. Heagy indicated that more paving will be done in 2025 and the purchase of a new boom mower was approved, so those are two of the large item expenses planned for 2025. However, Heagy advised the group that no tax millage rate increase is proposed. The proposed 2025 Budget is as follows:
