The meeting was called to order by Chairman, Edward Heagy. Heagy led the group in the Pledge of Allegiance to the American Flag.

Resident's Forum

Heagy invited questions/comments from the public.

Bob Adams – Mr. Adams was present to voice his disappointment in the passing of the Comprehensive Plan update. He indicated that he would like to have his whole farm zoned "Industrial." He disagrees with changing it to "Light-Industrial" and just wanted to express his opinion to the Board of Supervisors.

The Board of Supervisors pointed out that the zoning isn't officially changed by making these proposals in the Comprehensive Plan. The Public Hearing to consider amendments to the Zoning Map, including a portion of Mr. Adams' property, will be held on October 28, 2024 at 7:00 p.m.

Meeting Minutes Approval

Heagy advised that the Meeting Minutes from the Board of Supervisors' regular, monthly meeting held August 26, 2024 @ 7:30 p.m. and from the Special Session held September 23, 2024 @ 7:00 p.m. were prepared and ready for approval.

Wentling motioned to approve both of the Meeting Minutes listed in the above paragraph. Grubb 2nd the motion and with all three Supervisors voting in favor, the motion passed.

in favor, approval to pay the bills as presented was granted.

Annville Free Library – Marty Brandt and Dylan Fye

Marty Brandt spoke to thank the Board of Supervisors for their past monetary support of Annville Free Library. Brandt asked the Board of Supervisors if they would, again, consider supporting the library when they prepare their 2025 Budget and asked if they could consider raising their donation for 2025 as they are experiencing increased costs in utilities and they are working to be able to provide more favorable salaries for their paid staff.

Brandt introduced the new Director of the Annville Free Library, Dylan Fye. Fye advised that the building expansion project at the library has been completed. Study rooms and community rooms were added to the facility. Foot traffic at the library is up 30% over last year. All is going well.

Solicitor's Report - Collen Gallo, Attorney

No new items to report.

Township Manager's Report – Erik Harmon

Harmon submitted a written report for the Board of Supervisors to review.

Re. Trick-or-Treat Date – Harmon advised that Lebanon County has set the date for Trick-or-Treating as Thursday, October 31^{st} from 6-8 p.m. He suggested that the Board of Supervisors follow their lead and set the Township's date on the same night.

Grubb motioned to set Trick-or-Treat night as Thursday, October 31st from 6-8 pm for our Township. Wentling 2nd the motion and with all three Supervisors voting in favor, the motion passed.

Re. 674 Pine Road – Harmon advised that the property owner of 674 Pine Road, which is located in the same area as properties the Township acquired in the past through Hazard Mitigation Buyouts, has asked if the Township would be willing to accept transfer of the 674 property, with the condition that the Township pays for the settlement/title transfer costs. There are not buildings on the property.

Wentling moved to accept transfer of the property located at 674 Pine Road and pay for settlement/title transfer costs to do so. Grubb 2^{nd} the motion and with all three Supervisors voting in favor, the motion passed.

Attorney Gallo's office will take care of handling the transfer/settlement.

Road Foreman's Report – Howard Lerch

Lerch submitted a written report for the Board of Supervisors to consider.

Road Projects – Rettew

No report.

Planning Commission Report - Marvin Smith, Chairman

Re. Blatt & Tillett, 10630 Allentown Blvd – Minor Land Development Plan

Smith advised that the Planning Commission recommends the Board of Supervisors approve the Minor Land Development Plan contingent upon the applicant satisfactorily addressing all comments in the September 19, 2024, Light-Heigel review memo.

Wentling motioned to approve the Minor Land Development Plan for 10630 Allentown Blvd contingent upon the applicant satisfactorily addressing all comments in the September 19, 2024 Light-Heigel review memo. Attorney Gallo noted that the property owners have provided the signed O & M Agreement that is required. Grubb 2nd Wentling's motion and with all three Supervisors voting in favor, the motion passed.

Re. Kreider Farms, Pleasant View Road – Land Development Plan

Smith advised that the applicant has requested a 180-day extension to the plan review deadline. The current deadline is November 29, 2024. The extended deadline would be May 28, 2025. Nothing new, other than the extension request.

Heagy asked – "Are they having any luck getting the easements that they need to proceed?" Harmon replied – "They are getting ready to meet with the property owners."

Wentling motioned to grant the 180-day extension to the Kreider Farm plan review deadline, making the new deadline May 28, 2025. Grubb 2nd the motion and with all three Supervisors voting in favor, the motion passed and the deadline was extended.

Property Maintenance & Zoning Report - Erik Harmon

Harmon submitted a written report to update the Board of Supervisors regarding these matters.

Re. 10175 Jonestown Road – Consider 30-day Extension

Harmon feels this property can now be considered compliant. He will work with the Enforcement Officer to verify compliance. No extension needed.

Re. 1792 N. St. Rt. 934 – Consider 30-day Extension

Harmon indicated that some items have been brought into compliance at this location, however, there are some needs that still are not met. Harmon suggested granting one, last 30-day extension.

Grubb moved to grant a final 30-day extension on the matter. Wentling 2nd the motion and with all three Supervisors voting in favor, the motion passed.

Ono Sanitary Sewer - Ono Pump Station

Brad Youst, Hanover Engineering – A written report was submitted by Youst to update the Board of Supervisors as what projects he has completed.

Recreation Report - H.M. Levitz Memorial Park – Mike & Niccole Rice

A written report has been submitted by Rice for the Board of Supervisors to review.

Re. "2024 Breakfast with Santa" – Niccole Rice advised that they would like to hold the annual "Breakfast with Santa" event at the park on Saturday, December 14th. Rice asked for the Board of Supervisors' approval to proceed with the event.

Wentling motioned to approve the "Breakfast with Santa" event for Saturday, December 14th at H.M. Levitz Memorial Park. Grubb 2nd the motion and with all three Supervisors voting in favor, the motion passed.

Re. 20' x 40' Concrete Pad Installation at H.M. Levitz Memorial Park – Harmon asked the Board of Supervisors to consider a quote that he obtained to construct a 20' x 40' concrete pad at H.M. Levitz Memorial Park to be utilized as a game area by park visitors. Harmon advised that Mike and Niccole Rice advised him of a grant program that Pennsy Supply offers for community projects. Harmon applied for the grant funds to be used for this project and was awarded all of the stone and concrete that will be needed for this project. Therefore, Harmon obtained a bid from Little Mountain Concrete to construct the pad. The quote to perform that work is \$3,600.00.

Grubb moved to award Little Mountain Concrete the job of constructing the new concrete game pad for the quoted price of \$3,600. Wentling 2nd the motion and with all three Supervisors voting in favor, the motion passed.

Re. Patriot Cable – Patriot Cable, the internet service supplier to H.M. Levitz Memorial Park's caretaker home, has requested permission to attach a wireless transmitter to the Park Cabin. Harmon explained that Patriot Cable has requested permission to attach a wireless transmitter on the roof at the caretaker's cabin in order to provide service to a potential customer located along Bullfrog Road. Discussion was held on the matter. Ouestions to consider:

-Will the caretaker's cable service be affected by the installation of this device?

-Will the Township receive any type of compensation for allowing the device to be placed within the park?

-Is there a standard lease agreement to enter into if we decide to allow the installation?

Harmon will contact Patriot Cable to have further conversation with the management about this matter.

Re. Apple Cider Festival – Mike and Niccole advised that things are moving along nicely in preparation for the Apple Cider Festival that will be held on October 13th. As the ground has been very wet from the recent rainy weather, they are hoping things dry up a little before the event so that parking is not messy on that day.
