The Board of Supervisors convened in regular session at 7:30 pm.

Chairman - Matt Hetrick Present
Vice-Chairman - Edward Heagy Present
Secretary/Treasurer - Dennis Grubb Present

The meeting was called to order by Chairman, Matt Hetrick. Hetrick said due to the COVID-19 pandemic, the Township meeting is open for public attendance, in accordance with COVID requirements. Hetrick also advised that the meeting is being held electronically via Zoom.

Resident's Forum -

Rodney Weaver, 20 Homestead Road advised that the car crusher will remain on his property into May. The car crusher sets up in front of his property barrier for ease of operation. Weaver just wanted the Township to be notified.

Joe Still, 10 Zion Church Road informed the BOS that there are no vendors that provide a reliable internet service to his home. He has contacted Comcast, AT&T, Verizon, Blue Ridge and Frontier to inquire about internet services. All companies state that since there are currently no utility poles along that roadway to run above-head wires, the cost to run a line for this service would be \$25,000 plus. Still stated that his family has had great struggles with the limited Verizon internet access that is available to him, as his children have needed internet service for their school work during the pandemic and he is working from home needing internet usage as well. Still stated there are now federal funds available with the American Rescue Plan and is asking the Township to pursue utilizing those funds for expanding the broadband in the Township.

Larry Clionsky, 9 *Zion Church Road* stated he also would appreciate the Township pursuing federal money available to expand broadband service.

Clionsky stated that the abandon truck stop next to his property has 27 tractor trailers that have been there for years and years that have rodents coming in and out of the trailers. There are probably 200 tires and piles of trash. Supervisor Hetrick stated Clionsky should fill out a formal Complaint Form which Mickey Gartlan provided to Mr. Clionsky during the meeting.

Supervisor Grubb moved to approve the March 29, 2021 meeting minutes. Seconded by Supervisor Heagy. All voted in favor: motion carried.

Supervisor Heagy moved to pay the bills. Seconded by Supervisor Grubb. All voted in favor; motion carried.

Solicitor's Report - Colleen Gallo, Attorney

10244 Allentown Blvd - Gallo said the two agenda items on 10244 Allentown Blvd require serving the owner which has been challenging. The owner lives in Dauphin County so the Dauphin County Sheriff's Office serves the owner. Gallo stated she could file with the County to serve by Public Notification.

Supervisor Grubb moved to authorize Solicitor Gallo to file the necessary paperwork to serve the owner, Jim Halkias, by public notification. Seconded by Supervisor Heagy. All voted in favor; motion carried.

Indiantown Gap Road Culvert - Easement Agreements

Gallo referred to Jim Milot's report which provides an update of the easement agreements in detail.

10575 Allentown Blvd - Don Allison - On-Lot System Failing

Gallo indicated that Dave Siminitus, from Lebanon County Planning is addressing this matter. This item can be removed from the agenda for now.

Flood Plain Ordinance Changes

Gallo said the Township has decided to modify the current Flood Plain Ordinance to be less restrictive for accessory structures. The changes to accessory structures are provided and recommended by State and Federal agencies-Leslie Rhoades, FEMA representative and Marty Sowers, Light-Heigel Zoning Officer. Gallo is asking for the approval to move forward with the Flood Plain Ordinance changes which will be sent to the Planning Commission and County Planning for review.

Supervisor Heagy moved to authorize Solicitor Gallo to move forward with the Flood Plain Ordinance changes. Seconded by Supervisor Grubb. All voted in favor; motion carried.

Road Foreman's Report - Howard Lerch

Lerch reported the following maintenance occurred: equipment maintenance, patched holes in dirt roads, cleaned up trash and tires throughout the Township; Completed Indiantown Gap road drain pipes; oil and chipped on Indiantown Gap Road, Webster School, Bull Frog and Cold Spring Roads, and ordered material for the Indiantown Gap culvert project.

Yordy's Bridge Road Closing Due to Debris Clean-up

The bridge remains closed. A recent email update stated that the County is working with PennDOT to get an Underwater Inspection performed since the water has been so high recently. After the diving inspection, Wilson Consulting Group will inspect above water features and recommend to keep the bridge closed, open the bridge with same weight limit, or open bridge with revised weight limit. Wilson will inspect the bridge again in May as an Interim Bridge Inspection.

Heagy motioned to award stone items 1,2,3,4,5,6 & 7 to Pennsy Supply. Grubb 2nd the motion and with all three Supervisors voting in favor the motion passed.

Heagy motioned to award oil items 1, 2 & 3 to Russell Standard Corp. Grubb 2^{nd} the motion and with all three Supervisors voting in favor the motion passed.

Heagy motioned to award oil items 4, 5, & 6 (Superpave products) to New Enterprise Stone & Lime Co. Grubb 2nd the motion and with all three Supervisors voting in favor the motion passed.

(NOTE: it was later discovered that this company did not have a plant within the required 20 mile radius from the Township Building, so this bid was rejected and awarded to Pennsy Supply. That decision will be ratified at the May 24, 2021 Township Meeting.)

Midland Asphalts bid was unanimously rejected based on past performance with our Township.

Heagy motioned to award the paving project (Items 1, 2 & 3) to Pennsy Supply. Grubb 2nd the motion and with all three Supervisors voting in favor, the motion passed.

County Liquid Fuels Request for monies for Line Painting

The Township submitted a request to the County on April 21, 2021.

Thomas Graby, Terrace Lane Road Dedication

Supervisor Grubb stated PennDOT still has not been out to inspect this roadway in order for the Township to take over this road. Attorney Gallo stated she needs the deed description from the developer.

Supervisor Grubb moved to authorize Attorney Gallo to prepare a Resolution for Terrace Lane Road Dedication. Seconded by Supervisor Heagy. All voted in favor; motion carried.

Township Road Projects - Jim Milot, Hanover Engineering

Written report submitted and Jim Milot reported.

Kreider Poultry Operation – Because new submissions have not been received from the applicant, the draft application for PennDOT was automatically withdrawn by the PennDOT system. PennDOT was contacted to request the Kreider Farms Access HOP's be conditioned upon the roadway improvements HOP. In addition, the applicant's consultant was contacted to verify that they will initiate a new application.

Fort Indiantown Gap Road – Easements will be required for all 3 portions of this project. Awaiting response from the Gap representatives.

Fort Indiantown Gap Traffic Signal Ownership and Maintenance Transfer – Milot said he had received verbal confirmation this has been completed but is still awaiting confirmation from Mr. McCord/PennDOT.

Hanover Logistics Warehouse Projects – Copies of the land development plan submission were received for review of traffic and related aspects of the project. The Planning Commission requested the review of the timelines established for the Impact Fee Ordinance Capital Improvements Plan. The timeline started in 2018, therefore, since projects need to be initiated within 3 years of the CIP Schedule, the CIP timelines will need updated.

Broadband Infrastructure Letter Request

Supervisor Hetrick stated this was covered in the Public Comment section and directed Mickey Gartlan to pursue federal funding available for the expansion of broadband in the Township.

Planning Commission Report - April 15, 2021 - Tom Ehrhart

Written minutes were submitted and Ehrhart summarized the following:

Ehrhart said Jasen Geesaman, 1035 School House Road Stormwater Exemption Request was reviewed. No action was required or taken.

Flood Plain Ordinance Amendment for Accessory Structures - a motion was passed recommending the Board of Supervisors continue with the process for formally amending the Ordinance.

Justin Sauder, 88 Homestead Road Subdivision/Land Development Plan – a motion was passed recommending the Board of Supervisors conditionally approve the plan contingent that the comments in the Review letter have been addressed.

Michael Smith/Richard Shadel, 54 Dead End Road Subdivision Plan – A motion was passed recommending the Board of Supervisors conditionally approve the plan contingent that the comments in the Review letter are addressed.

Paul & Natalie Snyder, 39 Swatara Drive, Stormwater Exemption Request for SFD – plans are under review.

Hanover Logistics Warehouse Land Development Plan – The majority of development is in East Hanover, Dauphin County with stormwater facilities located in East Hanover, Lebanon County. A Riparian buffer between the two basins was changed since the last review in March.

Agricultural Zoning Ordinance Review – Steve Dellinger, Hanover Engineering said the County review deadline was April 12th. No comments were received. The motion was passed recommending the Board of Supervisors proceed with the process to formally amend the Ordinance.

Masayo Mesler, 55 Appalachian Drive – Request for 180-day extension.

The current 180-day extension request expires September 30, 2021. Attorney Gallo stated she communicated this will be the last plan extension that will be granted to Mesler's attorney.

Ehrhart said the Planning Commission started discussions on large solar farms and transit-oriented facilities such as warehouses.

Justin & Megan Sauder Subdivision/Land Development

The Planning Commission recommends the Board conditionally approve the plans contingent that the comments in the Light-Heigel Review Letter dated April 15, 2021 are addressed.

Supervisor Grubb moved to conditionally approve the Sauder Plans contingent that the comments in the Review letter have been addressed. Seconded by Supervisor Heagy. All voted in favor; motion carried. Bob Gearhart with Matthew and Hockley provided the signed O&M Agreement. Supervisor Grubb signed the agreement and gave to Attorney Gallo to notarize and record.

Michael Smith & Richard Shadel, 54 Dead End Road Subdivision Plan

The Planning Commission recommends the Board conditionally approve the plans contingent on the comments in the Light-Heigel Review Letter dated April 15, 2021 be addressed.

Supervisor Heagy moved to conditionally approve the Sauder Plans contingent that the comments in the Review letter have been addressed. Seconded by Supervisor Grubb. All voted in favor; motion carried.

Ordinance #2021-01 - Agricultural Zoning Ordinance Amendment - Steve Dellinger

The Planning Commission recommends the Board proceed with formally amending the Ordinance.

Supervisor Grubb moved to approve Attorney Gallo advertise the Public Hearing and prepare the documents for adoption. Seconded by Supervisor Heagy. All voted in favor; motion carried.

All agreed the Public Hearing would be held at 7:00p.m. prior to the May 24, 2021 Township Meeting. The Board requested Steve Dellinger attend the Public Hearing.

A written report was submitted and Henderson reported meeting with Jeff Falk with Lebtown for a story on H.M. Levitz Memorial Park.

The Post and Rail fence quote from Myerstown Shed and Fence totals \$4,893.62 which is a savings of \$1,543.09 from the original picket fence. The contract needs signed and they require \$1,615.00 or 1/3 down.

The Pond Trail safety fence, an Eagle Scout project for Luke Dresch, is expected to be completed the week of May 10th.

The Pond Trail sign is completed and will be installed in the next 2 weeks.

Supervisor Grubb moved to approve \$50 for the sign made by Northern Lebanon School. Seconded by Supervisor Heagy. All voted in favor; motion carried.

Henderson advised that the Northern Lebanon High School Seniors will be coming to the park for the annual work day on Monday, June 7th. Anticipated estimate costs are as follows:

Playground Mulch – 986.70

Regular Mulch - 600.00 + 400.00 = 1,000.00

Stain for Bridges - 431.60

Food & Drink for the Workers – 500.00

Grubb motioned to approve expenses up to \$2,900.00 for the NL Sr. Workday event. Heagy 2^{nd} the motion and with all three Supervisors voting in favor, the motion passed.

Henderson advised the Board of Supervisors that he is not going to have sufficient help to organize and run the Apple Cider Festival if they were to decide to hold the event in 2021. He also expressed his concerns with how to manage some of the events due to COVID restrictions. He asked for guidance from the Board regarding this matter. Grubb motioned to cancel the Apple Cider Festival indefinitely, with the understanding that if a community group would arise that would like to handle the event in the future, the Board could then consider approving the event again. Heagy 2nd the motion and with all three Supervisors voting in favor, the motion passed.

Maintenance includes: new springs for the garage door; new battery for vault toilet; working on campsites, trails and wood pile; regular park cleaning as required, weeding and grass cutting.

Levitz Memorial Park Pond Handicap Walking Trail - Union Township Grant Proposal

The Union Township Supervisors denied the funding request.

Supervisor Grubb stated he planned to attend the next Union Township meeting to inquire about working with East Hanover Township on their recycling access card program.

Ono Sanitary Sewer - Joshua Kreiser, Pump Station Operator / Brad Youst, Hanover Engineering

A written report was submitted by Brad Youst, Hanover Engineering.

Brad Youst reported: JEV Construction now has the specifications for the existing check valves and is working on valve rehab recommendations and the projected cost.

The Supervisors asked about the approved proposal progress. Sheila Seaman said she would contact Brad Youst regarding an update.
