The Board of Supervisors convened in regular session at 7:31 pm.

Chairman - Matt Hetrick Present Vice-Chairman - Edward Heagy Present Secretary/Treasurer - Dennis Grubb Present

The meeting was called to order by Chairman, Matt Hetrick. Hetrick said due to the COVID-19 pandemic, the Township meeting is open for public attendance, in accordance with COVID requirements. Hetrick also advised that the meeting is being held electronically via Zoom.

Resident's Forum -

Rodney Weaver, 20 Homestead Road advised that the car crusher will remain on his property into June and he is continuing to clean up. The car crusher sets up in front of his property barrier for ease of operation. Weaver just wanted the Township to be notified.

Solicitor Gallo stated an Executive Session was held at 7:00 p.m. tonight to discuss litigation with an on-going Zoning Hearing Board Appeal.

Marvin Smith, 10352 Allentown Blvd said some of the trailers on Zion Church Road that the Township received complaints on have come from his property. Smith said he is suing the previous owner, Jim Halkias regarding sewage issues on his property that was not disclosed at the time of purchase.

Smith also said the neighbors that live near the mounds of turf on the property at 10244 Allentown Blvd indicated that the turf material does smell in summer months. The neighbors have also told him they now have a bug infestation due to the turf.

Solicitor's Report - Colleen Gallo, Attorney

10244 Allentown Blvd - Gallo said the two agenda items on 10244 Allentown Blvd require serving the owner which has been challenging. The owner lives in Dauphin County so the Dauphin County Sheriff's Office serves the owner.

CNH Properties, 10244 Allentown Blvd

Engineering/Legal fees due totaling \$3,875.10. A letter/invoice was sent on August 12, 2020 and is now delinquent. Serving the owner is in process.

Gallo said she is in the process of filing an order with the Court to serve by public notification.

Indiantown Gap Road Culvert – Easement Agreements

Gallo referred to Jim Milot's report.

Flood Plain Ordinance Changes/Zoning Ordinance Amendment

Gallo said a Public Hearing would be advertised and held at 7:00 p.m. before the June 28th Township meeting followed by the Ordinance adoptions at the Township meeting.

The Supervisors asked that Steve Dellinger, Hanover Engineering be present for the Public Hearings.

Terrace Lane Road Dedication

Gallo stated she would need the Legal Description to prepare the road dedication documents. Supervisor Heagy asked Howard Lerch, Road Foreman about PennDOT inspecting the road. Lerch stated that Scott Lehman, our PennDOT representative, said that providing the developer put a top on the road and Howard finds the road acceptable, the Road Dedication can proceed. Lerch said as long as the paperwork is completed by September 1, 2021 the Township would receive the Liquid Fuels monies. Mickey Gartlan stated she would contact Bob Gearhart at Matthew and Hockley for the Legal Description.

Road Foreman's Report - Howard Lerch

Lerch reported the following maintenance occurred: tire collection; clean up after a high wind storm with down limbs and debris; cleaned AWOL road; equipment maintenance; oiled roads throughout the Township; hydraulic boom on the mower needs repair; delivered Indiantown Gap Road resident letters regarding paving that will take place next week.

Lerch reported after the recent heavy rains the run off from Linford Snyder's field required clean-up of 4" of mud on Coon Creek Road bridge. Lebanon County Conservation Department was contacted and performed an inspection. LCCD has turned it over to their Agricultural Department. Lerch reported there was erosion from the Boots & Hanks property also. The pipe size was adjusted and 3 truckloads of rocks were brought in. LCCD inspected this location as well. Boots & Hanks reported they are aware of the erosion problem and are looking at remedies.

Yordy's Bridge Road Closed Due to Debris Clean-up

Jon Fitzkee, with Lebanon County Planning /Transportation, reported on May 19, 2021 that Wilson Consulting Group will be issuing a letter that the bridge can be opened.

Line Painting Quotes

Lerch provide the following line painting quotes for 180,000' double yellow line:

Alpha Space Control 10.4 cents per lineal foot 11.9 cents per lineal foot 12.0 cents per lineal foot

Total would be approximately \$18,000.

Supervisor Grubb moved to award the line painting bid to Alpha Space Control. Seconded by Supervisor Heagy. All voted in favor; motion carried.

Supervisor Grubb asked Lerch if the Williams Pipeline road issue was corrected. Lerch stated it was not. Supervisor Grubb said he would contact Williams Pipeline regarding the matter.

Ratify awarding the Superpave bid to Pennsy Supply. Original bidder did not meet the proximity requirement.

Supervisor Hetrick stated that last month the BOS awarded the bid for Superpave products to New Enterprise Stone and Lime Co. as they were the low bidder. However, the BOS later learned that New Enterprise Stone and Lime Co. did not have a plant located within the required 20 mile radius from the Township Building. Therefore, the bid award was negated with New Enterprise Stone and Lime Co. and awarded to the next lowest bidder, which was Pennsy Supply.

Supervisor Heagy moved to ratify the Superpave bid to Pennsy Supply. Seconded by Supervisor Grubb. Al voted in favor; motion carried.

Township Road Projects - Jim Milot, Hanover Engineering

Written report submitted and Jim Milot reported.

Kreider Poultry Operation - Revised plans were received for review.

Fort Indiantown Gap Road – Easements will be required for all 3 portions of this project. Awaiting response from the National Cemetery representatives after project plans were forwarded to Randy Plummer, new contact since the last meeting. Milot learned that Fort Indiantown Gap and the Cemetery are two separate entities and the Cemetery is owned by the VA.

Fort Indiantown Gap Traffic Signal Ownership and Maintenance Transfer – Milot said he had received verbal confirmation this has been completed but is still awaiting confirmation from Mr. McCord/PennDOT.

Hanover Logistics Warehouse Projects –A revised submission was received and the review was coordinated with John Poff for the Planning Commission meeting.

A discussion took place regarding the National Cemetery easements, storing of all the construction material and general timing for the project. Road Foreman Lerch stated he worked with the Cemetery engineer regarding how to leave the markers in place.

Broadband Infrastructure Letter Request

Mickey Gartlan submitted a written report. Gartlan stated PSATS (Pennsylvania State Association of Township Supervisors) had an outstanding 28-page question/answer document regarding the American Rescue Plan monies and approved uses. The American Rescue Plan Act has allocated \$293,737 to East Hanover Township. \$146,000 will be received in June, 2021. \$146,000 will be received in June, 2022. All monies must be spent by 2024. Broadband expansion is an approved use of these funds.

Gartlan said she contacted State Representative Sue Helm and Congressman Dan Meuser. Meuser responded and provided a press release regarding broadband expansion and several links. No response was received from Helm.

Comcast provided an updated cost summary to expand in the area of Zion Church Road. The total cost for the expansion would be \$17,352 of which Comcast would need a contribution of \$12,244.

Patriot Cable runs along Park Drive. Their Engineer provided a rough estimate of \$40,000 to run cable to the Levitz Park cabin.

The Supervisors directed Gartlan to work with Comcast and look at additional areas to expand the broadband.

Planning Commission Report - May 20, 2021 - Tom Ehrhart

Written minutes were submitted and Ehrhart summarized the following:

Kreider Farms Poultry Operation, Pleasant View & Homestead Roads— a revised Highway Occupancy Permit plan was received and is being reviewed.

Conrad's Ole Mill, Route 934 – Stormwater Plan/Parking Lot Expansion

John Poff is setting up a meeting with Conrad, Lebanon County Conservation and Light-Heigel to discuss what are Conrad's plans.

Masayo Mesler, 55 Appalachian Drive – Revised Stormwater for SFD Final plan extension expires 9/30/21.

Agricultural Zoning Ordinance Amendment – Steve Dellinger, Hanover Engineering The Public Hearing will take place on June 28, 2021 before the June Township meeting.

The Planning Commission continues discussion regarding Solar Farms and Transit Oriented Facilities (Warehouses).

John Fitzkee, Lebanon County Transportation Department is anticipated to attend the June Planning Commission meeting to provide an overview of I-81 progress.

Ehrhart mentioned several years ago, the Planning Commission members would receive notification of upcoming Zoning Hearing meetings.

Justin & Megan Sauder - 80 Homestead Road - Subdivision/Land Development

Supervisor Grubb moved to ratify the approval and signing of the Final Subdivision Plans for Justin and Megan Sauder. Seconded by Supervisor Heagy. All voted in favor; motion carried.

Hanover Logistics - Pleasant View Road - Warehouse Land Development

The Planning Commission recommends the Board of Supervisors approve the following:

- 1. Approve the Request for a 60-day time extension that will expire on July 19, 2021.
- 2. Approve the waiver to process the plan as a combination preliminary and final plan. Supervisors Grubb moved to approve the request for 60-day extension that will expire on July 29, 2021 and approve the waiver to process the plan as a combination preliminary and final plan. Seconded by Supervisor Heagy. All voted in favor; motion carried.

<u>Paul & Natalie Snyder – 39 Swatara Drive – Subdivision/SFD land development/Stormwater Exemption</u> <u>Request</u>

Supervisor Grubb moved to approve the request for a 90-day time extension that will expire August 19, 2021. Seconded by Supervisor Heagy. All voted in favor; motion carried.

Jasen Geesaman – 1035 School House Road – Stormwater Exemption Request

A new Stormwater Exemption Agreement has been signed and presented tonight. The Planning Commission has reviewed. John Poff recommends the Board of Supervisors approve the Stormwater Exemption Request plan.

Supervisor Heagy moved to approve the Stormwater Exemption Request. Seconded by Supervisor Grubb. All voted in favor; motion carried.

Michael Smith & Richard Shadel, 54 Dead End Road - Final Subdivision Plan Approval

The Planning Commission conditionally approved the Subdivision Plan in April. John Poff recommends the approval of the Final Subdivision Plans.

Supervisor Grubb moved to approve the Michael Smith/Richard Shadel Subdivision Plan. Seconded by Supervisor Heagy. All voted in favor; motion carried.

Ordinance #2021-01 - Agricultural Zoning Ordinance Amendment - Steve Dellinger

All agreed the Public Hearing would be held at 7:00 p.m. prior to the June 28, 2021 Township Meeting. The Board requested Steve Dellinger attend the Public Hearing.

73 Harrison School Road - # of horses; building too close to property lines. Fence is now compliant. **Tanner Zoning Hearing Appeal** – The Oral Argument took place on May 7, 2021. An Executive Session took place at 7:00 p.m. prior to the Township meeting.

<u>Recreation Report</u> - <u>H.M. Levitz Memorial Park - Ross Henderson</u>

A written report was submitted and Henderson reported the following:

During May the Special Unit 66 Search and Rescue (dogs) and the Ono Pre-School were hosted. Henderson said the Envirothon was held via Zoom this year and has been scheduled for April 19th & 28^{th} next year.

The folks from Myerstown Shed and Fence will be out in about 8 weeks (July) to install the vinyl Post and Rail Pond fence. Luke Dresch completed the safety pond fence on May 19th which was an Eagle Scout project.

Henderson advised that the Northern Lebanon High School Seniors will be coming to the park for the annual work day on Monday, June 7th. Henderson said usually around 80 seniors participate, although this year the attendance expected is only 20-40 seniors. The Park is providing donuts, drinks and pizzas for the work event.

Maintenance includes: Ehrlich pest control was out April 27th; spread 45 cubic yards of playground mulch over 3 days; S. J. Moyer serviced the Cabin Central Air; working on trails and wood pile; regular park cleaning as required, weeding and grass cutting. The tractor needs front tires. Henderson is contacting Messick's, Zimmerman Farm Service and Lapp's Ag Tire service for pricing. Supervisor Heagy stated all 4 tires should probably be replaced.

Henderson said he will be on vacation June 25-July 5. Josh Kreiser will be covering the Park duties in his absence. Henderson asked permission for Kreiser be on the Township clock during this time.

Supervisor Heagy moved to approve Josh Kreiser to be on the Township clock while Kreiser fills in for Henderson's vacation. Seconded by Supervisor Grubb. All voted in favor; motion carried.

Sheila Seaman stated notification was received that the Lebanon County juvenile case that involved the individual arrested in connection to the break-in and vandalism at Levitz Park, was transferred from Lebanon County to Dauphin County as requested. All juveniles involved will now be processed through the Dauphin County Courts.

Ono Sanitary Sewer - Joshua Kreiser, Pump Station Operator / Brad Youst, Hanover Engineering

A written report was submitted by Brad Youst, Hanover Engineering. Youst reported he has received a proposed scope and cost from JEV Construction for the rehabilitation of the Ono PS valve vault. The work would involve sandblast, prime and paint of the components within the valve vault, replacing the two check values, and replacing the check valve on the vault drain line that discharges into the wet well. The value of the proposal exceeds the threshold requiring multiple proposals, so Youst will attempt to find two additional contractors who could submit cost proposals for consideration.

Kreiser reported that Walters cleaned the wet well.

<u>Diane Ferguson, 10718 Jonestown Road – Request permission to connect to Ono Sewer System/1 EDU</u> capacity

Diane Ferguson has requested 1 EDU of sewer capacity and the approval to connect to the Ono Public Sewer.

Supervisor Grubb moved to approve Diane Ferguson, 10718 Jonestown Road to connect to the Ono Public Sewer with 1 EDU reserved capacity. Seconded by Supervisor Heagy. All voted in favor; motion carried.

Matthew Witmer, 47-49 Main Street – Request reduction from 3 to 2 EDU

A written request was still pending at the time of the meeting. Supervisors agreed to table until a written notice is received.
